A partial refund will be given to individuals requesting a refund for any other reason if requested <u>prior to the first game at Jamboree</u> (full refund minus a \$10 administrative fee). In the case that an injury prevents further participation the partial refund will be issued based on time in season and costs incurred. No refund will be given if the refund is requested after the team's first scheduled game.
